6. PETITIONS AND DELEGATIONS

a) Robert Powell and Karen Cameron-Powell request for Transfer of a portion of Municipal water lot.

Karen and Robert Powell, owners of the Lakeview Lodge, and Dennis Johnson were present to update Council on the progress of their project, which is to develop a marina that would allow boats to dock and have access by water to their business. Mr. Johnson stated that they were seeking confirmation from Shuniah that it would be willing to transfer a portion of its waterlot. He presented Council with copies of a letter from Lakehead Region Conservation Authority along with underground pictures of the crib.

He explained that the LRCA were requesting the owners to obtain a study from a Costal Engineer, which could be quite costly for a small business. They had already retained a local engineer, one whom Ocean and Fisheries believes to be qualified. He noted that as Shuniah is a member of this organization that is requesting support to allow the local engineer to do the study. The Clerk was directed to discuss this with the Chief Administrative Officer.

The Powell's require a sliver of the waterlot, about one acre and are asking if Shuniah would be willing to transfer this portion of waterlot in exchange for the work of removing the crib, which is currently a liability. Mr. Powell explained that he would haul rock from crib, then use it to build the marina, and use the boulders for construction of the break wall.

The Manager of Operations informed Council that he has dealt with similar liabilities with respect to municipal docks; and believed it advisable to remove the crib.

Mr. Johnson is requesting a resolution from Council in support of transferring the water lot in exchange for services in the elimination of the hazard and liability, noting that the Powells would be responsible to obtain all the

necessary permits. Councillor Giardetti stated he would like to see the water lot come back to Shuniah if the project does not take effect. Mr. Johnson requested a realistic time frame with a minimum of at least 3 years and if the resolution could reiterate Shuniah's support in principle for the Powell's project.

The Clerk was directed to prepare a resolution of support and to obtain a legal opinion on the liability of the crib.
