MUNICIPALITY OF SHUNIAH

Being a by-law to set various user fees and to repeal and replace By-law 3209-21.

## **Recitals:**

- a) The Municipality of Shuniah has established fees, rates and user charges for a variety of service that are now outdated.
- b) Council deems it expedient to further repeal and replace By-law No. 3209-21 to update existing user fees and charges

THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF SHUNIAH ENACTS AS FOLLOWS:

- 1. That various fees, rates and user charges are hereby established as set out in Schedule "A" attached to this By-law.
- 2. Any conflict of fees outlined in any other by-law passed prior to the date of passing of this by-law; the fees as set out in Schedule "A", as may be amended from time to time, shall prevail.
- 3. That By-law No. 3209-21 is hereby repealed.
- 4. That Schedule "A" be an integral part of this by-law.
- 5. That this By-law shall come into force and take effect upon final passage hereof.
