BY-LAW NO 3393-24

Being a by-law to set various user fees and to repeal and replace By-law 3357-24.

Recitals:

- a) The Municipality of Shuniah has established fees, rates and user charges for a variety of services including the rental fees of municipal recreation centers.
- b) The Municipality of Shuniah has completed the construction of the New Multi-Use Pavilion.
- c) Council deems it expedient to further repeal and replace By-law No. 3357-24 to update and include user fees and charges for the rental of the New Multi-Use Pavilion.

THEREFORE THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF SHUNIAH ENACTS AS FOLLOWS:

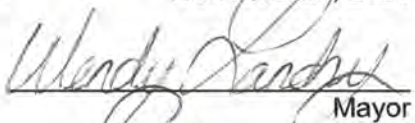
1. That various fees, rates and user charges are hereby established as set out in Schedule "A" attached to this By-law.
2. Any conflict of fees outlined in any other by-law passed prior to the date of passing of this by-law; the fees as set out in Schedule "A", as may be amended from time to time, shall prevail.
3. That By-law No. 3357-24 is hereby repealed.
4. That Schedule "A" be an integral part of this by-law.
5. That this By-law shall come into force and take effect upon final passage hereof.
